EBAC Ski and Snowboard Club Report for EBAC General Membership Meeting 2/6/2025 by Bryce Knight

The ski and snowboard club held its first trip for the 2025 winter season to Jay Peak Vermont on Jan 17-20. We had 128 people go on this trip and the conditions were excellent with 100% of the mountain open and even some fresh snow while we were there.

Our next trip leaves this Friday 2/7 for Neiseko Japan and will return on Feb 18. We have 57 people going on that trip and are excited for our first club trip to Japan!

Our biggest trip of the year, in terms of attendance, is Smuggler's Notch VT and will be February 28 – March 2. This trip is closed for sign-up and we are working on finalizing arrangements for the 178 people signed up. The following trips are currently open for sign up:

EBAC Varsity Ski and Snowboard Racing Update 1/28/2025 by Matt Aven Race Results:

- 1/7/2025 Tied for 2nd place out of 8 teams. This was the highest nightly point total and position EBAC had placed since joining the Connecticut Industrial Ski Council (CISC) league in 2021. We also beat Sikorsky (SK) and both Pratt & Whitney teams! [Presented at the January EBAC Gen Membership Meeting]
- 2. 1/14/2025 Hit by several illnesses, a personal conflict, and an equipment issue, but were able to piece together a 6-person team for 291pts. We came in 6th behind SK, however still held our lead by 1pt for the total on two weeks.
- 3. 1/21/2025 Teammates were healthy and the team was back to nearly full strength. One of our top point earners was out on work travel, but another racer was back for the first time this season from an illness and came in first in his division. We tied for 3rd place at 297pts with OR&L.
- 4. **1/28/2025** Another couple racers out sick, but had a solid team of 7 show and put up 297 points for a 4th place. We extended our lead over Sikorski to 10pts.
- 5. 2/4/2025 Impacted by a couple work conflicts and absences. Again pulled together a solid team of 7 and had a surprise early visit from one of our veteran snowboarders to cover for two that were out this week taking 1st and maintaining EBAC Varsity Team's dominance over the 15M category (Snowboard, Male, 16-44). We tied for 2nd with 297 points. Dropping our worst weeks' results allowed us to close the gap on 3rd place to 4pts but also continued to increase our lead over Sikorsky to 14pts.
